Coordinated Outreach Events and Programs

- August 10 CiTi BOCES Migrant Education Tutorial & Support Summer Program, hosted storytimes for three classes and distributed 39 books.
- August 10 CiTi BOCES METs End-of-Summer Celebration, tabled with Amanda Buell (SOD) and Kate Karnisky (WIL) to distribute 90 backpacks with school supply bundles, 40 Merriam-Webster's Word-for-Word Spanish-English Dictionary, and 61 books; registered nine new library card holders; and had a button-making station.

LIBRARY COMMUNITY UPDATES

Legislative Updates

- NYLA plans on asking for the same state aid and construction aid amount as last year.
 - \$147.1M (Aid); \$69.4M (Construction Aid)
 - \$99.6M (FY 2023 Enacted); \$34M (FY 2023 Enacted)
- NYLA's Preliminary Policy Initiatives Include:
 - o Intellectual Freedom/Anti-Book Ban Legislation
 - o Prohibition of Non-Discourse Agreements (this is a school library item)
 - o Data Privacy Laws (not an initiative, but something they will monitor)
 - NOVELNY (Libraries need to decide how best to move forward with this item)
- Libraries Are Education Most likely the collective message for 2024.
- 414 Petition Reduction (S3594/A5266) Passed Senate and Assembly
- Library Materials Definition Digital Expansion (S5986/A6807) Passed Senate and Assembly
- LCA 50% Cap Elimination (S7093) Passed Senate, still in Committee for Assembly
- Book Fair Tax Exemption(S5955A/A5538B) Passed Senate, still in Committee for Assembly
- Freedom to Read Act (S6350B/A6873B) Passed Senate, still in Committee for Assembly
- Library Capital Funding Study (S1418) Passed Senate, still in Committee for Assembly

Draft bills related to book banning:

- New York Assembly Bill 7878:
 - "No library or library system shall receive state aid pursuant to this section unless such library or library system adopts the American Library Association's Library Bill of Rights that indicates materials should not be proscribed or removed because of partisan or doctrinal disapproval or, in the alternative, develop a written statement prohibiting the practice of banning books or other materials within the library or library system. A library or library system shall adopt such Bill of Rights or develop such written statement within

ninety days of the effective date of this subdivision¹."

- New York Assembly Bill 7843:
 - "No library or library system shall be eligible for state aid unless such library or library system has included as part of their operating plan or has established policies incorporating the provision of the American Library Association's Library Bill of Rights that indicates that materials should not be proscribed or removed because of partisan or doctrinal disapproval or has developed a written statement prohibiting the practice of banning books or other materials within the library or library system and prohibits the practice of banning specific books or resources²."
- New York Assembly Bill 7830
 - "Every free association library, public library, hospital library, Indian library and library system which receives any portion of moneys appropriated by the state shall adopt the American Library Association's library bill of rights that indicates materials should not be proscribed or removed because of partisan or doctrinal disapproval or, in the alternative, develop a written statement prohibiting the practice of banning books or other materials within the library or library system...

Each school district, board of education, trustees or such body or officers as perform the functions of such boards shall adopt the American Library Association's library bill of rights that indicates materials should not be proscribed or removed because of partisan or doctrinal disapproval or, in the alternative, develop a written statement prohibiting the practice of banning books or other materials within any school library which receives aid for the purchase of school library materials³."




Figure 1 OverDrive Conference




Figure 2 OverDrive Conference




Figure 7 600 Books by Mail Bundles!




Figure 8 Drive Thru Baby Showers in Wayne County
