New Open Meetings Legislation Passed

Governor Cuomo signed legislation on January 3rd that applies to records scheduled to be discussed during an open meeting, including proposed resolutions, laws, rules, policies and amendments. The legislation requires state and local governments to post materials online before a meeting, or provide copies before or at the meeting "when possible." As all public libraries in New York State – including association libraries – are subject to the Open Meetings Law, my assumption is that libraries will need to comply. More information will follow once the Committee on Open Government has updated their website. The law takes effect 30 days from January 3rd.

Reminder: Check in Hold Items on Delivery

Items delivered to the library to fill holds must first be individually checked in before checking them out to patrons. Checking in items upon delivery tells Evergreen that the item has been delivered and received, and changes the copy status from *in transit* to *on holds shelf*. If this step is skipped, the item's copy status will change from *in transit* to *checked out* and the system will:

- continue to view the hold as unfilled
- target items at other libraries in order to satisfy it.

As redundant items arrive at the library, the patron will receive "Hold Available" notifications, even though they already have the requested item in hand. ◆

Why can't your patron find the bestseller they want in OWWL2go? It isn't because I have missed it (95% of the time). I purchase all the new titles that are available. I purchase all the fiction bestsellers as soon as they are available. Geneva is responsible for the nonfiction. I also try to catch up on back titles in series when a series title becomes a bestseller. I check the holds list twice a week and add another copy when the holds ration hits 5/1. I add titles from the BookLetters lists. I maintain a "Considerations" list based on LJ's Prepub Alert. I read Early Word for titles getting a lot of press. I use OverDrive's lists of titles they have just added. We now have a "Suggest a Title" tab on the OWWL2go page and I generally handle these every day. I submit orders to OverDrive at least twice a week. Items are in OWWL2go within minutes of the order being submitted. These are my weekly and sometimes daily collection development activities for OWWL2go.

I appreciate feedback on what patrons want. I know the frustration when the title you really want isn't there. It must be understood however, that four of the six major publishers do not allow OverDrive to provide their titles in eBook format. We cannot get ebooks published by St. Martin's, Macmillan Simon & Schuster, and Penguin (as of December 2011) and their imprints. Last year most libraries voted to not obtain HarperCollins titles when they went to the 26 loan limit per copy. Most libraries have now changed their position on that and I am now adding HarperCollins titles. But some libraries still don't want their funds used for HarperCollins titles, whether they are bestsellers or not. But *the bottom line is, if OverDrive doesn't have, I cannot add it.*

This is an issue of great importance about which the library community and publishing community are at odds right now. Publishers feel threatened by libraries providing free access to ebooks. ALA is working to overcome this bias, but for now, library patrons need to be educated that it isn't out of neglect or even lack of funding that we don't provide what they want. It is because the **publishers** don't want libraries to provide it to them. This is an entirely new obstacle we face in delivering services to our users.

OWWL Catalog Comes Alive with Book Reviews & Ratings

The Pioneer Library System announced today its newest enhancement – ChiliFresh Review Engine. ChiliFresh adds social interaction to the OWWL.org online catalog by allowing community users to contribute and read book reviews of the materials available in the collections of the 42 public libraries in Ontario, Wayne, Wyoming and Livingston counties. The new service has been made possible by a grant from the Harold Hacker Fund of the Rochester Public Library Foundation.

ChiliFresh is a subscription service that integrates reviews from its 3500+ participating libraries across the United States, Canada, the United Kingdom, Australia, New Zealand and Hong Kong. The system is configured to show reviews from OWWL users first, so local reviews will appear at the top of the list.

"We have become accustomed to sharing with others before making decisions on how to spend our time and resources," said Cassie Guthrie, Executive Director of the Pioneer Library System. "We are happy that residents in the Pioneer system can now have that same experience at the library when it comes to choosing books."

As with other types of review sources, reviews are ranked by number of stars. Reviews can be sorted by most useful (based on readers' reactions to the review), newest, oldest, highest-ranking and lowest-ranking review. To read and write reviews, visit www.OWWL.org and search for materials. Reviews and ratings appear automatically within the catalog results. A link to "write a review" appears below the book jacket cover.

Headquartered in Canandaigua, the Pioneer Library System is a New York State chartered cooperative public library system serving the 42 mostly small and rural public libraries in Ontario, Wayne, Wyoming and Livingston counties.
